

Cynllun Cymorth Tanwydd Gaeaf	Winter Fuel Support Scheme
<p>Annwyl randdeiliaid a phartneriaid,</p> <p>Fel rhan o becyn cymorth ehangach o dros £50m i fynd i'r afael â phwysau ar gostau byw ar hyn o bryd, mae Llywodraeth Cymru wedi rhyddhau dros £38 miliwn drwy'r Cynllun Cymorth Tanwydd Gaeaf.</p> <p>Ar 1 Chwefror 2022, cyhoeddodd y Gweinidog Cyfiawnder Cymdeithasol estyniad i'r cymorth i aelwydydd drwy ddyblu'r Cynllun Cymorth Tanwydd Gaeaf gan gynyddu'r taliad o £100 i £200. Bydd hyn ar gael i ymgeiswyr newydd ac yn cael ei ôl-dalu i'r rhai sydd wedi gwneud cais eisoes.</p> <p>O 13 Rhagfyr 2021 tan 28 Chwefror 2022, mae'n bosibl y bydd modd i bobl gymwys yng Nghymru hawlio taliad untro o £200 gan eu cyngor lleol er mwyn rhoi cymorth tuag at dalu eu biliau tanwydd gaeaf.</p> <p>Fel rhanddeiliaid a phartneriaid allweddol, mae Llywodraeth Cymru yn awyddus i fanteisio ar eich sianeli cyfathrebu i'n helpu i rannu'r neges â chynulleidfaoedd, gan wneud yn siŵr eu bod yn ymwybodol o'r cynllun a sut i wneud cais. Felly rydym wedi casglu pecyn o adnoddau i'ch helpu i rannu negeseuon am y 'Cynllun cymorth tanwydd gaeaf' â'ch cynulleidfaoedd.</p>	<p>Dear stakeholders and partners,</p> <p>As part of a wider support package of over £50m to address immediate pressures on living costs, Welsh Government has made available a Winter Fuel Support Scheme.</p> <p>On the 1st of February 2022 the Minister for Social Justice extended support to households by doubling the Winter Fuel Support Scheme, increasing the payment from £100 to £200. This will be available to new applicants and retrospectively paid to those who have applied already.</p> <p>From the 13 December 2021 to 28 February 2022 eligible people in Wales may be able to claim a one-off £200 payment from their local Council to provide support towards paying their winter fuel bills.</p> <p>As key stakeholders and partners, Welsh Government would like your communication channels to support getting the message out to audiences, ensuring they are aware of the scheme and how to apply. We have therefore put together a toolkit of resources to support you in communicating the 'Winter fuel support scheme' to your audiences.</p>

Bydd ymgeisydd yn bodloni'r amod hwn os bydd yr ymgeisydd (neu bartner yr ymgeisydd) yn gyfrifol am dalu biliau tanwydd ar y grid i'r darparwr ynni ar gyfer eiddo yng Nghymru ac os mai prif breswylfa'r ymgeisydd yw'r eiddo. Mae'r amod hwn wedi'i fodloni ni waeth a fydd yr ymgeisydd yn talu am danwydd ar y grid drwy fesurydd talu ymlaen llaw, drwy ddebyd uniongyrchol neu drwy dalu bil bob chwarter. Nid yw'r amod hwn wedi'i fodloni os bydd ymgeisydd (neu bartner yr ymgeisydd) yn talu am danwydd oddi ar y grid.

Bydd cynghorau lleol yn cysylltu ag aelwydydd cymwys i ofyn iddynt wneud cais lle mae modd iddynt nodi y gallent fod yn gymwys i gael y taliad tanwydd gaeaf.

Eligible households can claim a one-off £200 payment from their local council to provide support towards paying their on-grid winter fuel bills. The payment will be available to all eligible households regardless of how they pay for their on-grid fuel, whether that is, for example, on a pre-payment meter, by direct debit or by paying a bill quarterly.

The scheme is open to households where one member is in receipt of certain welfare benefits.

An applicant meets this condition if they (or their partner) are in receipt of one of the qualifying working-age means tested benefits at any time during the qualifying period 1 December 2021 to 31 January 2022.

These qualifying benefits are:

Income Support, or

- Income-Based Job Seekers Allowance, or
- Income-Related Employment & Support Allowance, or
- Universal Credit, or
- Working Tax Credits

Applicants must also be responsible for paying the energy bills for the property.

An applicant meets this condition if they (or their partner) are responsible for paying on-grid fuel bills to their energy provider for a property in Wales and this property is considered their primary residence. This condition is satisfied regardless of whether on-grid fuel is paid for through a pre-payment meter, by direct debit or via quarterly bill. This condition is not satisfied if an applicant (or their partner) pays for their fuel off-grid.

Anyone who requires financial assistance with off-grid fuel costs (such as oil, Liquefied Petroleum Gas (LPG) or coal) can consider applying to the [Discretionary Assistance Fund](#) for help.

Local councils will be contacting households to invite applications where they can identify potential eligibility for the winter fuel payment.

However, anyone who believes they are eligible for the payment can submit a claim via their local council's website from 13 December 2021. All
